Bellbrook to Spring Valley Connector Trail RE:

Project Description:

The proposed Bellbrook to Spring Valley Connector Trail has been contemplated by community members in Greene County for over two decades. The Little Miami Scenic Trail is both a recreational asset as well as an economic development powerhouse that has remained just out of reach to our communities in southwestern Greene County. The proposed connector trail between Sugarcreek/Bellbrook's Sacket Wright Park and the Little Miami Scenic Trail just outside the small and economically diverse Spring Valley Village would allow pedestrians, bicyclists and other mobility device users of all ages a safe mode of travel between these communities and all they have to offer. Currently, driving between these areas is the most prevalent, with significant risks taken by users of active transportation modes given the speed of traffic and lack of any infrastructure for active transportation users.

Given the objectives of this project, the ideal alignment for the Bellbrook to Spring Valley Connector Trail will follow the path of SR 725 on the north side of the road from Sackett Wright Park in Sugarcreek/Bellbrook to the Little Miami Scenic Trail in Spring Valley with a separated bridge crossing over the Little Miami River. At this point, all major stakeholders, including the Ohio Department of Transportation, have been engaged and fully support moving forward with this project. Resolutions of support from Sugarcreek Township, the City of Bellbrook, Spring Valley Township and Spring Valley Village have been passed with appropriations from Sugarcreek Township to fund preliminary engineering. Additionally, Greene County Parks and Trails, Greene County Regional Planning, the Ohio Department of Transportation and the Bellbrook Sugarcreek Park District fully support this initiative. This is a viable project that has been contemplated for many years and we feel a duty to our constituents and our communities. to see it constructed.

Community Benefits:

Overall, there are significant economic, health, safety, recreational and environmental benefits associated with the Bellbrook to Spring Valley Connector including:

- Providing a safe travel route for all ages, abilities and income levels using all transportation modes;
- Supporting economic development by providing increased access to the downtowns of Bellbrook and Spring Valley Village to ensure that our communities thrive;
- Promoting active lifestyles, decreasing such issues as obesity and lowering health care costs;
- Facilitating access to recreational opportunities through increased access to Sackett Park and Morris Reserve;
- Reducing automobile traffic and congestion while promoting health; and
- Helping various entities deliver on their goals, enhancing mental health, economic opportunity and quality of life.
